Analytical/performance cookies	These cookies allow us to recognise and count the number of visitors and to see how visitors move around the Website when they are using it. Functionality cookies	These are used to recognise you when you return to the Website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region). By using the Website, you agree to our placement of functionality cookies.
Targeting cookies	These cookies record your visit to the Website, the pages you have visited and the links you have followed. We will use this information to make the Website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.
